1. Honorarium payments to tour guides will be \$_____ per "tour session."

2. Tour Guides will need to participate in a Tour Guide training session to be eligible.

3. Tours Sessions will be limited to _____

4. For all Tour Guide honorariums, the Tour Guide must participate for a minimum of two hours during the Tour Session.
